Scope of this policy

- Commercial Operator Training Solutions Ltd (we or us or our) uses cookies when you visit our
 website www.cotstraining.co.uk (the Website), to help customise the website and improve your experience
 using the Website.
- 2. This policy applies between you, the user of this Website, and us, Commercial Operator Training Solutions Ltd, the owner and provider of this Website.
- 3. When you visit the Website, and before your website places cookies on your computer, you will be presented with a message bar requesting your consent to set those cookies. Analytical/performance cookies	These cookies allow us to recognise and count the number of visitors and to see how visitors move around our Website when they are using it. This helps us to improve the way our Website works, for example, by ensuring that users are finding what they are looking for easily.
Functionality cookies	These are used to recognise you when you return to our Website. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or region). By using the Website, you agree to our placement of functionality cookies.
